After deep fundamental analysis these businesses are purchased at a discount to our estimate of intrinsic value.

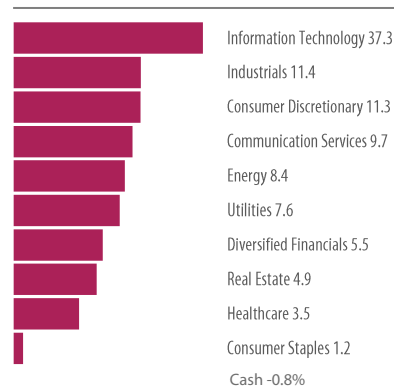

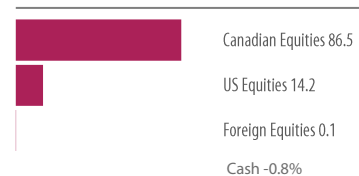

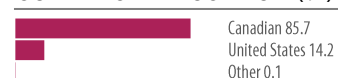
SECTOR ALLOCATION (%)



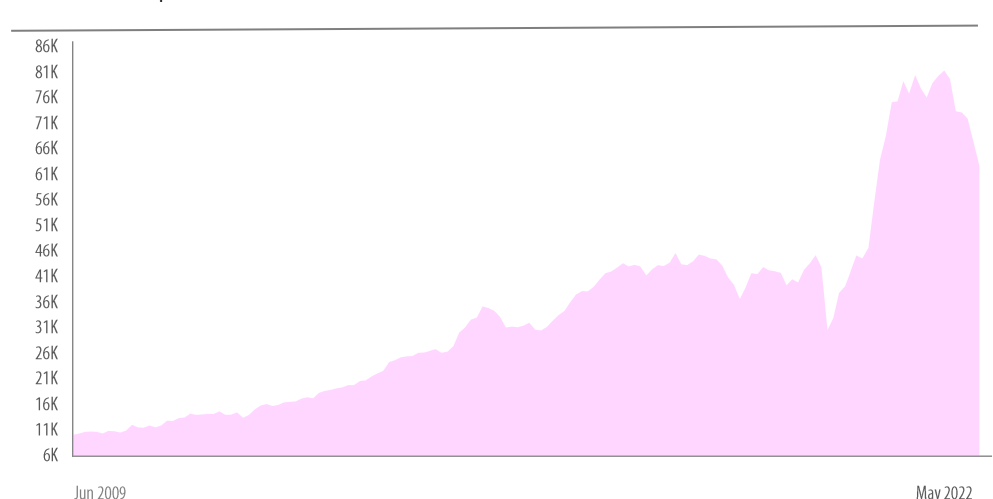
ASSET ALLOCATION (%)
