#### What does the fund invest in?

The Fund will invest primarily in companies whose operations are primarily located in emerging market countries and whose business models are of high quality and possess positive and sustainable earnings growth potential. Equally important, as part of its impact investing strategy, the Fund will be strongly aligned and committed to considering environmental, social and governance (ESG) factors when evaluating potential investments in the portfolio.

#### How risky is it?

The value of the fund can go down as well as up. You could lose money. One way to gauge risk is to look at how much a fund's returns change over time. This is called "volatility".

In general, funds with higher volatility will have returns that change more over time. They typically have a greater chance of losing money and may have a greater chance of higher returns. Funds with lower volatility tend to have returns that change less over time. They typically have lower returns and may have a lower chance of losing money.

#### Risk rating

**Pender has rated the volatility of Class N of the fund as medium.**

Because this is a new fund, the risk rating is only an estimate by Pender. Generally, the rating is based on how much the fund's returns have changed from year to year. It doesn't tell you how volatile the fund will be in the future. The rating can change over time. A fund with a low risk rating can still lose money.

## How has the fund performed?

## Who is this fund for?

This Fund is suitable for investors who want to maximize the long-term potential growth of their capital. Investors in this Fund should have a long-term investment time horizon and a medium tolerance for investment risk. This Fund is not suitable for those with a low tolerance for risk in their returns or for those who have a short or medium time horizon for their investment.

## A word about tax

In general, you pay income tax on your share of the fund's earnings and on any gains you realize from redeeming your investment. The amount of tax depends on the tax rules and rates that apply to you, and whether you hold the fund in a registered plan, such as an RRSP or TFSA.

Keep in mind that if you hold your fund in a non-registered account, fund distributions are included in your taxable income, whether you get them in cash or have them reinvested.

## How much does it cost?

The following tables show the fees and expenses you could pay to buy, own and sell Class N units of the fund. The fees and expenses – including any commissions – can vary among classes of a fund and among funds. Higher commissions can influence representatives to recommend one investment over another. Ask about other funds and investments that may be suitable for you at a lower cost.

### 1. SALES CHARGES

There are no sales charges for Class N units of the fund.

### 2. FUND EXPENSES

You don't pay these expenses directly. They affect you because they reduce the fund's returns. The fund's expenses are made up of management fees, administration expenses and trading costs, exclusive of taxes. The Class N annual management fee is 0.30% and its administration fee is 0.50% of the class' value, exclusive of taxes. Because this class is new, its expenses and costs are not yet available.

### More about the trailing commission

No trailing commission is paid by Pender to your representative's firm in respect of Class N securities.

### 3. OTHER FEES

You may have to pay other fees when you buy, hold, sell or switch units of the fund.

Fee	What you pay
<b>Short-term trading fee</b>	You may be charged up to 2.00% of the value of units you sell or switch within 30 days of buying them. This fee goes to the fund.
<b>Switch fee</b>	Your representative's firm may charge you up to 2.00% of the value of units you switch to another class of the fund or to another fund managed by Pender.

### What if I change my mind?

Under the securities law in some provinces and territories, you have the right to:

- withdraw from an agreement to buy mutual fund units within two business days after you receive a simplified prospectus or Fund Facts document; or
- cancel your purchase within 48 hours after you receive confirmation of the purchase.

In some provinces and territories, you will also have the right to cancel a purchase, or in some jurisdictions, claim damages, if the simplified prospectus, annual information form, Fund Facts document; or financial statements contain a misrepresentation. You must act within the time limit set by the securities law in your province or territory.
