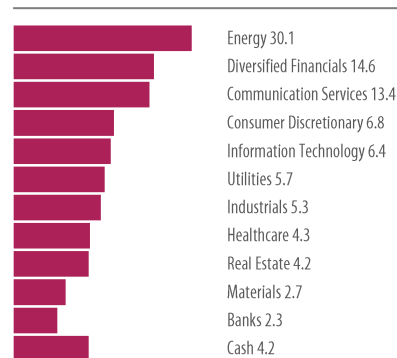

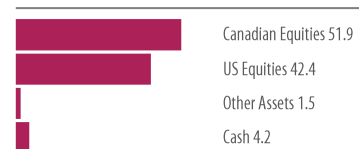

### SECTOR ALLOCATION (%)



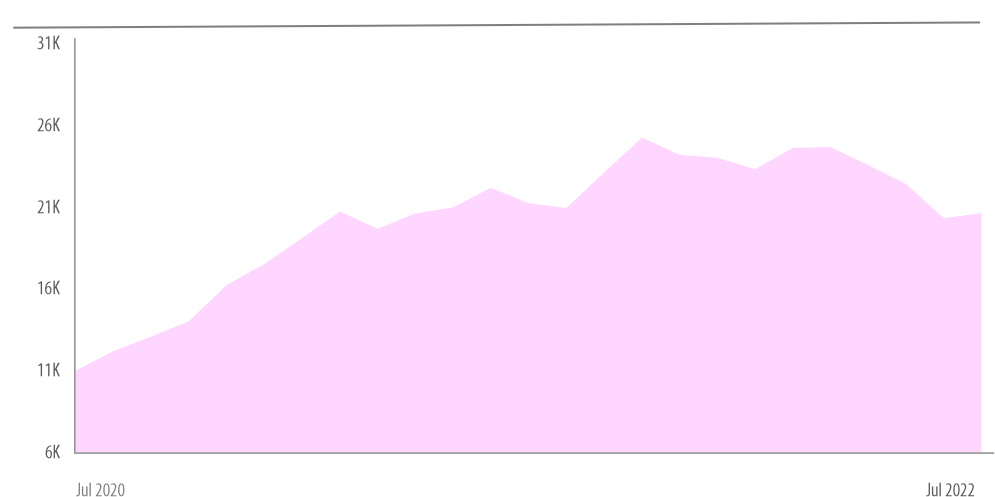
### ASSET ALLOCATION (%)
