More about the trailing commission

The trailing commission is an ongoing commission. It is paid for as long as you own the fund. It is for the services and advice that your representative and your representative's firm provide to you. 







































The fund invests primarily in North American securities. The fund may also invest in foreign and other securities. The fund will use alternative investment strategies including the use of leverage. The leverage will be created through the use of cash borrowings, short sales and derivative contracts. The fund's leverage must not exceed 300% the fund's net asset value. The leverage will be calculated in accordance with the methodology prescribed by securities laws.

How risky is it?

The value of the fund can go down as well as up. You could lose money. One way to gauge risk is to look at how much a fund's returns change over time. This is called "volatility".

In general, funds with higher volatility will have returns that change more over time. They typically have a greater chance of losing money and may have a greater chance of higher returns. Funds with lower volatility tend to have returns that change less over time. They typically have lower returns and may have a lower chance of losing money.

Risk rating

Pender has rated the volatility of Class I (US\$) of the fund as low.

This rating is based on how much the fund's returns have changed from year to year. It doesn't tell you how volatile the fund will be in the future. The rating can change over time. A fund with a low risk rating can still lose money.

Who is this fund for?

In general, you pay income tax on your share of the fund's earnings and on any gains you realize from redeeming your investment. The amount of tax depends on the tax rules and rates that apply to you, and whether you hold the fund in a registered plan, such as an RRSP or TFSA.

1. SALES CHARGES

There are no sales charges for Class I (US\$) units of the fund.

2. FUND EXPENSES

You don't pay these expenses directly. They affect you because they reduce the fund's returns. Pender waived some of the fund's expenses. If it had not done so, the MER would have been higher. The fund's expenses are made up of management fees, administration expenses and trading costs, exclusive of taxes. The Class I (US\$) annual management fee is 0.65% and its administration fee is 0.50% of the class' value, exclusive of taxes. The fund will pay to the Manager a performance fee in relation to Class I (US\$) units that is equal to 15% of the amount by which the total return of the Class I (US\$) units exceeds its high-water mark for the period since the performance fee was last paid, exclusive of taxes. The performance fee is calculated as described in the Simplified Prospectus on a daily basis and paid annually. As of December 31, 2022, the expenses of Class I (US\$) were 1.56% of the value of this class. This equals USD \$15.60 for every USD \$1,000 invested. Class I (US\$) performance fee was waived at December 31, 2022.

What if I change my mind?
